- 4. I will indemnify and save harmless the Releasees from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities whatsoever brought against the Releasees or incurred by the Releasees for any reason as a result of my participation in the Event.

I agree that the resulting recordings and photographs will be the sole and exclusive property of the Organizer, and I hereby give the Organizer permission to use, publish or display my name, photographs and recordings in whole or in part in any manner and in any media to promote the Event.

These conditions and any rights, duties and obligations as between the undersigned and the Organizer shall be governed and interpreted solely within the laws of Austria and Germany and any litigation involving any Releasee and the undersigned will be brought solely within Austria and Germany and will be within the exclusive jurisdiction of the Courts of Austria and Germany.
- 7. In signing this Waiver, Release of Liability and Assumption of Risk Agreement, I am relying on my own judgment. I am not relying on any oral or written representation or statements of any kind made by the Organizer or any other Releasee, including without limitation any statements made by the Organizer or any other Releasee to induce me to participate in the Event.

I FULLY UNDERSTAND ITS TERMS AND HEREBY REPRESENT TO THE ORGANIZER THAT I AM SUFFICIENTLY PROFICIENT IN THE ENGLISH LANGUAGE TO DO SO. I FULLY UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND THAT IT IS BINDING UPON ME, MY HEIRS, EXECUTORS AND ADMINISTRATORS. I AM SIGNING IT VOLUNTARILY WITHOUT ANY INDUCEMENT.
